Minutes of Board Meeting December 19, 2018 at 5:30 PM

The Board approved the minutes to the November 26, 2018 Board meeting.

The Board passed Resolution 2183 approving Watervliet Housing Authority invoices paid from November 26, 2018 to December 19, 2018 since the last monthly meeting.

The Board passed Resolution 2184 establishing the 2019 salary compensation for WHA Non Union employees.
